

## **(1) Questions and Answers:**

**Question #1:** Do the variants on page 3 of the RCO include the base system pouches or are they in addition to?

**Answer:** Variants are subcomponents of the base system (i.e., in addition to the base system pouches) and are priced separately from the base system pouches (see pages 5-9 of the RCO).

**Question #2:** The 1 quart canteens are not specified in any configuration. Should we be attempting to house the canteen(s) on the ALC, or will the user do that once received?

**Answer:** The user will determine the placement of the 1 quart canteen.

**Question #3:** Is there a specific (brand name) tubular hydration system that the USMC will buy for use with the ALC? Or, is there a tech sheet that we may use for reference?
